

Terms and Conditions for Singapore @ Home Watch Party Funding Programme

On 6 August 2022, come join us in celebrating our nation's 57th birthday with a global live show, "Singapore @ Home" hosted by Hossan Leong and Siti Khalijah! Catch appearances from local talents such as Audrey Luo and Dwayne Lau, as well as musical performances by Annette Lee and Benjamin Kheng, Taufik Batisah, Joanna Dong and Kartik Kuna. This is an online extravaganza not to be missed! The show and other exciting content will be available on demand till 9 August 2022, 2359SGT.

If you are interested to organise a **Singapore @ Home Watch Party** funded by the Singapore Global Network (SGN), please note that you will need to meet the following requirements:

- a. The gathering can be either virtual or physical, where attendees tune in to the virtual "Singapore @ Home" event;
- b. The watch party must be held between 6 August 2022 to 9 August 2022;
- c. There must be a minimum attendance of 5 adults;
- d. Minors under 16 years old can be included in the expected number of attendees, but supporting evidence of their presence is needed (ie. group photos of total number of attendees must be provided.)
- e. All attendees (with the exception of minors aged below 16 years old) have to fill in their personal details and submits respective data required by SGN in the form. Each attendee must use a unique email address, whereby the submission of the same email address will be rejected by the system.

You will be contacted via email on the results of the application once it has been approved. Within the email, we will also provide the link to an online registration template where all attendees (excluding minors below 16 years old) will need to submit with their details, consent to SGN's privacy statement and agreement to be added to SGN's mailing list. To enable post-event reimbursement, the following documents must be provided **within 2 weeks of the watch party**:

- a. The applicant is to ensure that all watch party attendees aged 16 years old and above had provided the following details via the link:
 - i. His/her personal contact information and occupational details;
 - ii. Consent to SGN's privacy statement; and
 - iii. Agreement to be added to SGN's mailing list.
- b. Proof of watch party and express consent for the physical/virtual event photo(s) to be used on SGN's social media;
 - i. **For a physical watch party:** Please provide a group photo(s) of all attendees, inclusive of attending children, with the Singapore @ Home Programme clearly shown on the TV screen/monitor in the background.
 - ii. **For a virtual watch party:** Please provide a screenshot of all attendees in the call, as well as the Singapore @ Home screen, preferably in one image. If you are using Zoom, switch to Gallery View to take the screenshot.

- c. SGN will require the applicant of the watch party funding to fill up:
 - i. [Bank details form here](#), together with a screenshot of a section of the bank statement of account, where the account holder's name, bank account number and bank name are reflected.
 - ii. Post-event report form, which will be sent across in the confirmation email. If the report is approved, the applicant will be reimbursed SGD 20 for each adult and SGD10 for each child who attended the watch party. Do note that it may take up to 2 months for reimbursement to be disbursed after submission of the details.
